# Gift aid declaration and standing order mandate

#### Introduction

Gift aid is the government's incentive scheme to encourage the public to give to charities. For every £100 the Church receives in gift aided donations we can claim a further £25 from the government (equal to the basic rate income tax deducted from this income when you earned it in the first place). Higher rate or additional rate tax payers can claim back the remaining tax and this is refunded directly to you – speak to the Treasurer if you want further help in claiming this tax back (contact details at the end of this leaflet).

### Who is eligible?

Anyone who pays enough income tax or capital gains tax in the year to cover the amount we reclaim from the government. Most people in paid employment will fall into this category and many people on a pension or with large investment income may well also be eligible.

You may feel that you are borderline and are unsure if you will pay enough tax in the year. If this is the case we can always wait until the end of the tax year before making the claim – speak to the Treasurer if this applies to you.

#### What do you need to do?

All you need to do is provide us with your name and address and make a declaration that you are paying income tax or capital gains tax at the required level (see previous section) and will inform us if this changes. The declaration is printed on the next page.

You must then ensure that when you make a donation we know it comes from you. This is most easily done by setting up a standing order (a form for doing this is also included on page 3).

Alternatively, if you wish to give by cash or cheque (made payable to "St Andrew's Church") then we can provide you with numbered buff envelopes – speak to Sue Franklin if you wish to do this (contact details can be found below). Please note that it costs us more in time and bank charges to process cash and cheque donations so standing orders are preferable.
